SAE Plan - Market Lamb 2015 - 2016

Description

In my Market Lamb 2015 - 2016 SAE project, I plan to raise a market lamb while learning the proper care of livestock. I plan to show my lamb at prospect shows, and eventually take my lamb to TCYS. I am interested in the animal science area of agriculture, for at the moment I desire to become a veterinarian when I am older. This experience could help me understand the basic care of large animals, and help me in the future to become a large and small animal vet. This SAE project began on the fifth of September, and will continue until the 17th of January. I have taken no classes in this area of expertise, however I am learning basics of livestock in my Principles of Agriculture class, and I will take livestock production next school year. I plan to learn how to balance my time to work with my market lamb, raise livestock, show animals, become more responsible, learn good showmanship, and learn how to manage a financial investment. I also hope to make some money at TCYS through my market lamb if possible.

Time Investment

For my Market Lamb 2015 - 2016 SAE project, I plan to devote my time to the farm. I shall wake up and spend 30 minutes with my lamb in the morning- feeding and working with him, as well as an hour every evening in order to ensure that he shall be fully prepared for the County Show. I shall work around my other commitments by going to the farm late on Tuesdays after Symphony rehearsal, and going to the farm late on Mondays, Wednesdays, and Fridays, after tennis practice. My mom shall feed my lamb while I am in the aforementioned rehearsals and practices, so that once I get to the farm all I have to do is work with my lamb. My parents will also assist me with bleaching out my lambs pen on the weekends as I work with my lamb in the practice show ring. Mr. Pierce has mentioned a trip to San Angelo in order to learn the techniques of showmanship, so once a date is declared for the trip, I shall make time for it.

Financial Investment

My budget for this SAE project is approximately \$850, It will cost \$550 for this project to start in order for me to buy my lamb, and it will cost approximately \$20 dollars for feed about every 3 weeks. Also, it will cost approximately \$30 dollars to register for shows throughout the year. During the time of my SAE I may be forced to buy animal care products such as fungicide, ace wrap, shampoo, and disinfectant. These managing and care necessities should equal about \$75 dollars. I hope to receive \$1000 dollars at auction bringing my income to about \$200 dollars. The source of my funds for this SAE is my parents. They support my endeavors through my SAE and are willing to support me with finances. I will also use "non-cash" benefits through the school. I will rent a pen through the school by giving a \$100 dollar deposit that will be returned at the end of the year. Through the school I will have access to feces disposal, a shearing stand, a treadmill, bath house, and an animal blow dryer. I will also have access to a walker and a practice pen. When using these "non-cash" benefits I will return them as they were lent to me, and I will attempt my best to keep them clean in order to thank the school for allowing me to use them. These "non-cash" benefits' values are expensive, and it is my responsibility to ensure that they are kept fashionable at all times.

My project involves the usage of capital items through the school. I will rent a pen through the school by giving a \$100 dollar deposit that will be returned at the end of the year. Through the school I will have access to feces disposal, a shearing stand, a treadmill, bath house, and an animal blow dryer. I will also have access to a walker and a practice pen. When using these capital items and facilities I will return them as they were lent to me, and I will attempt my best to keep them clean in order to thank the school for allowing me to use them. These "non-cash" benefits' values to my project, are insurmountable. Without these "non-cash" benefits, I would not be able to raise a market lamb, and it is my responsibility to ensure that they are kept fashionable at all times. I will also be using the school's land to train my market lamb. When using the school's land I must ensure that I act in the best way that represents my school, and treat the land with respect as it is not mine. Overall all capital items that I shall use, will be treated with respect as though they were my own. The school will provide me with each of these capital items.

Learning Objectives (SAE Skills)

From my project, I hope to gain knowledge and skills in AS.02.03.01.a Identify ways an animal's health can be affected by anatomical and physiological disorders, AS.02.03.02.b Assess an animal to determine if it has reached its optimal performance level based on anatomical and physiological characteristics, and AS.03.01.02.c Treat common diseases, parasites and physiological disorders of animal.

I will achieve these project learning objectives by raising a market lamb. I will learn how the physical environment such as rain, bird droppings, and to much feed physically harm an animal with diseases. I will then learn how to treat these diseases by deworming and giving Corid. Finally I will learn how to judge animals to physically assess whether it has reached its optimal performance level. If it has not, I will work my animal harder and develop a workout routine.

This project is related to topics learned in my Principles of Agriculture Class, and it shall correlate to the rest of my agriculture pathway throughout high school, especially next year in my Livestock Production class. This also relates to my FFA committee, farm maintenance. Also this relates to my future career plans, for I plan to become a large and small animal vet. This experience can teach me how to learn basic care of large animals, which will help me experience the basics of animal care. At the end of this project, I feel the outcomes have taught me how to work well with others in a showman arena, how hard work pays off, and finally how the only way to reach success is to put the work in yourself. I have also learned how to properly maintain the nutrition and weight of a lamb, as well as proper showmanship techniques.
